TERMS

TUITION PAYMENTS

Current CMA Students:

CMA has contracted with Smart Tuition to handle billing, tuition payments and collections. The payment due date will be either the 1st, 3rd, or 5th of each month based on your selection within Smart Tuition's enrollment process. Smart Tuition's \$40 late fee/insufficient funds policy will take effect if you are late or have insufficient funds, in addition to a \$15 late fee charged by CMA. CMA reserves the right to make a determination on cancelling enrollment if payment is not collected in a manner consistent with Smart Tuition/CMA policy for any two or more months. A late payment does not negate your contractual obligations with CMA.

Students from the Outside Community:

Enrollment Fee is due upon initial enrollment in CMA's Summer Camp program. The Supply Fee and first Tuition payment are due **June 1, 2020**. The second Tuition payment is due **July 1, 2020**. Tuition is late after the 3rd of each month and will incur a \$30 late fee. If Tuition and Late Fee are not paid in full by the 10th of each month, student(s) may not attend Summer Camp until amount due is paid in full.

Summer Camp is staffed based on initial enrollment and as such, there are no refunds for monies paid, tuition is not prorated, and tuition cannot be carried over from the previous month. Camp ends July 31, 2020. *Students enrolled in CMA for the Fall 2020, will be the only students allowed to attend classes once school begins on August 13th.*

Hours/Extended Day:

CMA opens at 7:30am and closes promptly at 5:30pm. There is no charge for before-camp care.

Extended Day is available for an additional charge. Extended Day begins at 3:30 pm and ends promptly at 5:30 pm for those students enrolled in the summer program. There is a substantial charge of \$15 per 5 minutes per child (which is *not* prorated), for picking up your child after 5:30 pm. Please make every effort to be on time — our staff thanks you!

For those students not enrolled in the program, there is a grace period from the end of the school day which is 3:00 to 3:29 pm in which to pick up your child. Extended Day begins promptly at 3:30 pm at an hourly rate of \$7 (which is *not* prorated). Children not enrolled as attending students are not allowed to play on the play-ground or in the Extended Day room due to insurance liability.
